ON Chapter Education Day — October 13th, 2017

The day started with a Year in Review presentation by the CHIMA Executive Team, Gail Crook, CEO and Registrar and Tamara Stefanits, Vice President with a focus on the history of CHIMA and a glimpse into the future of the Health Information Management Profession.

The next two guest speakers highlighted the very positive work of the National Surgical Quality Improvement Program (NSQIP) and how the Surgical Clinical Review role is perfect for HIM professionals. The first portion ,as presented by Pierrette Price Arsenault , identified the program which is managed by Health Quality Ontario. The focus of the presentation was in regards to the history of the program and the expectations from the Ontario program. The second part ,as presented by Carol Adam, Manager HIS/CPO at Collingwood General & Marine Hospital, provided a real hospital scenario highlighting significant improvements in Surgical Site Infection rates at the hospital since participating in the program. NSQIP helps surgical teams focus on specific Quality Improvement initiatives and CGMH and has even included their Resident program in completing QI initiatives. The next item on the agenda of the day focused on the rolling out of the EHR for Ontarians which was presented by Sue Schneider, Director, eHealth Standards at eHealth Ontario. Sue provided an overview of the provincial EHR implementation and discussed the standards that are used with the implementation. The provincial EHR will provide better information for better health care, providing access by credentialed clinicians to access information on their patients from any location across the province. Nancy Andrews, Manager of Privacy & Information Security at Health Sciences North put a personal spin on her presentation which focused on sharing personal health information in a regional HIS system. Pam Nelson, Advanced Clinical Systems Strategist at Health Sciences North also provided insight into the implementation of a Regional HIS system.

The day ended with Karanne Lambton of Life Fulfilled Coaching providing the audience with actions to help them reach their highest potential and become engaging leaders.

The ON Chapter of CHIMA had a DQ session planned for December 2016; however, due to technical issues the session had to be cancelled and re-scheduled. The session eventually took place at the Grand River Hospital February 9th, 2017. The session was well attended with over 580 HIMs registered and over 90 facilities registered (80 of which via OTN). The focus of that session was Sepsis.

In 2017, the ON Chapter of CHIMA had a call out for new members on the Data Quality Committee and vacancies were filled very quickly. The current committee membership consists of nine members including one from Whitehorse. The committee convened in July to start preparing for the December 4th, 2017 data quality session which was hosted by Niagara Health Systems in St. Catherine's Ontario and was attended by 600 members throughout the province. The focus of the session was GI Endo QBP/Gastrointestinal. We were happy that CIHI was able to continue their involvement. We also had Cancer Care Ontario participate and talk to coders abut the GI Endo OBP.

A follow-up survey provided excellent feedback which the planning committee will use for future sessions, including many suggestions for future topics. The respondents to the survey indicated that 73.6% felt that their expectations were met and most find the OTN process to be the most useful.

The ON Chapter of CHIMA is pleased to announce we are planning to host another Data Quality Session at some point during the 2018/2019 fiscal year. Stay tuned for further details.

The Personal Health Information & Protection Act (PHIPA) went through a revision in 2016 and new sections came into force on October 1st, 2017. ALL Health Information Custodians (HIC) are now required to collect information on all breach activities within their organization and will begin reporting this data to the Information and Privacy Commission in January 2019 for the 2018 calendar year.
