

WHO WE ARE

The Canadian Health Information Management Association (CHIMA) is a national organization and certifying body that represents over 5,000 Health Information Management (HIM) professionals across the country. Our association seeks to: promote the HIM profession, expand the job market for our members, facilitate continuing education, influence the direction of professional practice, and monitor industry trends.

The Canadian College of Health Information Management (CCHIM) is the registering and regulatory body for the HIM practice and profession in Canada. CCHIM is responsible for standards setting in relation to HIM education and HIM certification. CCHIM accredits certificate, diploma and degree programs in colleges and universities across Canada. HIM programs in Canada must receive CCHIM accreditation for program graduates to meet the eligibility requirements to write the National Certification Examination (NCE). In addition to setting initial standards, CCHIM ensures ongoing adherence to the professional practice and operational standards.



Health Information and Education Credentialing

In an effort to better position HIM professionals for success, CHIMA and CCHIM underwent eight months of discovery to determine how the profession can continue to meet the current and future needs of the health care industry.


Our discovery — the HIM Innovation Project — has been inclusive and without restriction, involving stakeholders inside and outside HIM, and seeking to chart a course for the profession over the next 15 to 20 years.

HIM Innovation Project: What did we do?

- ▶ Held one-on-one in-person, phone, and video interviews
- ► Hosted group discussions (3-8 people), round tables (8-20 people), and presentations (70+ people)
- ► Engaged in storytelling and focus groups with health care actors across the country
- Invited key stakeholders to share their input into CHIMA's strategic objectives
- Made innovative education and credentialing a focal point for engagement with the CHIMA board, HIM program coordinators, chapter advisory committees, and industry leaders in the field


Director of Health Information Management, Central Zone Alberta Health Services

By all accounts, Nicole has had a successful career in the health care field. As a medical office assistant and transcriptionist, she held various management roles before completing a HIM program and earning the CHIM credential. Having worked with the Ontario Ministry of Health and Long-Term Care, as a director of HIM, and as a consultant, Kathy has spent her career in health care. Throughout her various roles, she began to focus on using clinical data to drive funding. Realizing that her true interest was in the finance side of health care, Kathy earned her CPA designation in 2016 and took on the role of CFO at Woodstock Hospital.

Despite no longer working in a direct HIM role, Kathy says her heart is still in CHIMA. "I'm one of very few CFOs with a health information background — but I think it is tremendously beneficial, because clinical data is driving a lot of the funding." She places a continual focus on her hospital's data quality efforts to maximize funding for their patients. And just as she benefitted from meeting mentors and future bosses from her time on the CHIMA board, she encourages young HIM professionals, advising them to see and experience as much as they can within their field.

FINANCIALS

Summary

The following is a report of the Canadian Health Information Management Association and Canadian College of Health Information Management (together, the organization) consolidated financial results for fiscal year 2018/19.

The 2018 Conference in Niagara and Professional Development offerings resulted in higher than expected revenue. Combined with cost control efforts, a positive net income was generated for the organization. These factors position CHIMA for growth and investment against our strategic plan.

We retained PricewaterhouseCoopers LLP to audit the Organization. The audit report was based on Generally Accepted Accounting Principles (GAAP) and has a clean opinion.

The following is an excerpt, dated May 16, 2019, from PricewaterhouseCoopers LLP:

"In our opinion, the accompanying combined financial statements present fairly, in all material respects, the financial position of the Canadian Health Information Management Association and Canadian College of Health Information Management (together, the Organization) as at February 28, 2019 and the results of its operations and its cash flows for the year then ended in accordance with Canadian accounting standards for not-for profit organizations."
